3. a) That the object of the trust shall be relief of the poor, education, medical relief and advancement of any other objects of general public utility not for purpose of profit, its income shall be applied and accumulated fully for charitable purpose.
- b) To set up, run and manage educational institutions at all levels, including technical, higher education management and business colleges, teachers training institutions engineering colleges, medical colleges and other institutes of learning.
- c) To help the poor and needy widows, orphans and other destitutes by awarding them or their children educational aid, stipends or scholarships, rendering financial help for marriages, to help down-trodden and deserving children financially and otherwise to educate them in the matter of their settlement leading clean and healthy life, improve their standard of living to render medical relief to the poor patients, to install water coolers at public places, and institutions connected with any of the object of the trust and to undertake any other activity for general public utility.

- b) To manage the trust properties for the time being and to do all the acts necessary for the preservation, maintenance and management of the trust and / or trust properties.
- c) To invest the trust fund and its accretion thereof and / or any part thereof and the income of the same as the trustees may think fit and proper according to the provisions of any law for the time being in force.
- d) To sell or give on rent or on hire or lease any immovable or moveable property of the trust for such period or periods on such terms conditions as the trustees may think fit and proper.




